Dr. Milton, Health Authority of Public Health and Casie Stoughton, Director of Public Health, discussed the COVID – 19 Pandemic in the community.

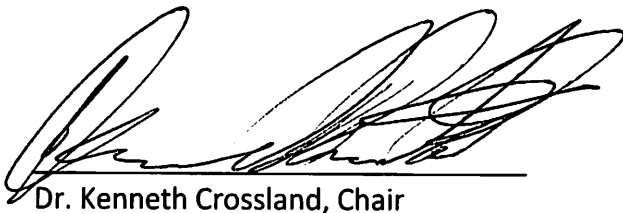
There were no comments from interested citizens on matters directly pertaining to policies, programs, or services of the Amarillo Area Public Health Board.

Item 7: Discuss Items for Future Agendas

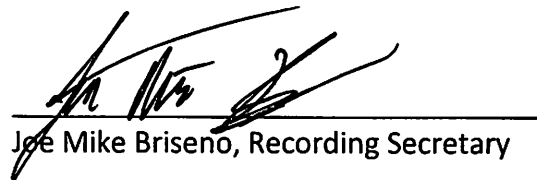
