ITEM 2: Approval of the May 6th, 2021 Board of Review for Landmarks, Historic Districts, and Downtown Design meeting minutes.

ITEM 3: COA-21-12 Consideration of variances from the Downtown Amarillo Urban Design standards pertaining to walkway improvements related to The Pergola Shop Project located on Lots 6 and 7, Block 401, Mirror Addition, in Section 155, Block 2, A.B.&M. Survey, Potter County, Texas.

Vicinity: SE 10th Ave. and Johnson St.

Applicant/s: Tommy Krause for Krause Landscape Contractors, Inc.

Jason Taylor, Planner I, gave the above presentation. The applicant is proposing to develop the existing pedestrian pathway that will require two variances, a variance from the standard pedestrian pathway width of seven feet and a variance to utilize single globe lights instead of double globe lights due to existing site constraints. Staff believes that if approved, the variances are a minor departure from the typical DAUDs standards and will still visually have the same positive impact on an area that is a major corridor and currently absent of such improvements. Staff recommends approval of both variances as presented.
