REGULAR MEETING

Call to Order.

Committee Chairman Rogers called the scheduled regular meeting of the Amarillo City Pedestrian and Bicycle Safety Advisory Committee to order at 11:14 a.m.

Item 1: Public Forum.

No Public Forum.

Item 2: Review of Minutes from Last Meeting.

Committee Chairman Rogers asked if there were any changes to make for the approval of the April 19, 2021 minutes. Committee Member Smith made a motion to approve the minutes. Committee Member Ingalls seconded the motion, and motion carried 3:0.

ITEM 3: The Committee will discuss or receive reports on the following current matters or projects:

A. APD High Accident locations an hot spots

Haley Hernandez, Crime Data Analyst with APD, gave a report on the high accident locations and hot spots around town. The report showed over the last five years vehicle accidents involving pedestrians on I-40 & Grand, I-40 & Whitaker, South Coulter and 45th, I-40 & Soncy. The report showed pedal cyclists accidents over the last five years at 10th & Georgia, S.E. 24th & Ong, Olsen & Hobbs, North Taylor & N.E. 15th.

There is a total accident report that has been presented to the Traffic Advisory Board.

Chairman Rogers inquired about comparing higher traffic accident volumes to other Cities similar in size.

B. Frontage roads for Bike Lanes

Donny discussed the frontage roads for bike lanes. He mentioned Bell St. and 45th. He looked back at the Master Plan and those areas are not included. The frontage roads are generally 33 ft and 37 ft back to back on the curbs. There would need to be room for a parking lane and a bike lane along with a buffer zone. They're a challenge because there is no connectivity. Committee Member Ingalls mentioned curb cuts and sharrows.

C. Update on Amarillo Blvd. Pedestrian Crossings

Donny updated the Committee. The agreements have been signed by TXDOT. The funding has been approved by both TXDOT and City of Amarillo. Construction should start after July 4th on the HAWKS. The plans for funding phase 2 for the intersection upgrades should be completed by December 2021. The plans for phase 3 will be mid 2022. There is one being completed right now at Caprock High School.

D. Update on Bike Lanes

Donny stated that 7th St. is 80% complete. There will have to be 39 signs on 7th St. and 42 pavement markings. It will cost \$1,800.00 a year to maintain. 8th St. is 85% complete with 48 signs and will cost \$1,600.00 a year to maintain. Johnson St. is almost complete with 14 signs and 53 pavements markings and will cost \$1,000.00 a year to maintain. Julian from 15th to I-40 has 126 signs with 323 pavement markings and will cost \$6,500.00 a year to maintain. On North Coulter St. from Fairway to Francis are stripes that are being put in that will run both directions that ties into Tascosa Road has 15 signs with 28 pavement markings and will cost \$2,000.00 a year to maintain. There was press release sent out to let citizens know that the traffic patterns have changed. Donny also mentioned that there are plans to put some educational pieces out talking about different issues inside Public Works.

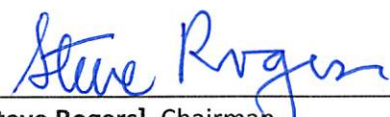
Members agreed to schedule the next meeting date on August 16, 2021.
