Buchanan, St., Amarillo, Texas, on June 14, 2021. The subjects to be considered at this meeting are as follows:

D: Rezoning of 78.98 acres consisting of land in the Mathew Hooks Re-Subdivision of Block 49 Miller Heights, Miller Heights, North Heights, Clarence Watley's Subdivision of Wheatley's 5 Acre Tract, and University Heights Additions, plus one half of all bounding streets, alleys, and public ways to change from Multiple-Family District 1 to **Moderate Density District**, in Sections 168 and 189, Block 2, AB&M Survey, Potter County, Texas.

E: Rezoning of 29.17 acres consisting of land in the Miller Heights, North Heights, and University Heights Additions, plus one half of all bounding streets, alleys, and public ways to change from Multiple-Family District 1 with Specific Use Permit 85 and Multiple-Family District 1 to **Neighborhood Service District**, in Sections 168 and 189, Block 2, AB&M Survey, Potter County, Texas.

VICINITY: North Heights Neighborhood Plan Area (north-portion of Plan Area)
