(This is the opportunity for visitors and guests to address the Condemnation Appeals Commission on any issue. 2. **Approval of Minutes** This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on March 16, 2023.
3. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:** This resolution sets the date and time for a public hearing on May 18, 2023, at 4:00 p.m. to determine whether certain conditions of the properties located at 4209 SE 15th Avenue, 3405 Hancock Street, and 617 N Pierce Street (aka 312 NE 7th Avenue and 316 NE 7th Avenue) constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.
4. **Resolution – Public Hearing** This resolution conducts a public hearing on and considers ordering the removal of substandard structures and an accumulation of solid waste located at 3000 Curtis Drive.

The City Council reserves the right to discuss all or part of any item in an executive session at any time during a meeting or work session, as necessary and allowed by state law. Votes or final decisions are made only in open Regular or Special meetings, not in either a work session or executive session.
