2. Minutes

This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on January 19, 2023.

3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on March 16, 2023, at 4:00 p.m. to determine whether certain conditions of the properties located at 2031 NW 13th Avenue, 204 S Carolina Street, and 1933 S Van Buren Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

4. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 705 S Houston Street.

5. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures and an accumulation of solid waste located at 2008 NW 16th Avenue.

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 1104 SW 20th Ave Rear (aka 1105 W Interstate 40).
