4. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:** This resolution sets the date and time for a public hearing on March 6, 2025, at 2:00 p.m. to determine whether certain conditions of the properties located at 1407 NW 17th Avenue, 1405 N Bonham Street, 206 N Madison Street, 401 N Tennessee Street, 508 N Tyler Street, 1446 NW 12th Avenue, 1924 NW 12th Avenue, 902 S Bivins Street, and 504 N Hughes Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

The Condemnation Appeals Commission reserves the right to discuss all or part of any item in an executive session at any time during a meeting or work session, as necessary and allowed by state law. Votes or final decisions are made only in open Regular or Special meetings, not in either a work session or executive session.
