- B. **CONSIDERATION OF ORDINANCE NO. 7915:**

This item is the second and final reading of an ordinance considering annexing

approximately 191.07 acres of land into the city limits. This is a landowner-initiated annexation request and the land is currently vacant. Anticipated development will consist of an Industrial/Business Park. Vicinity: Georgia Street and Farmers Avenue. Applicant/s: Amarillo Economic Development Corporation.

C. CONSIDERATION OF ORDINANCE NO. 7916:

This item is the second and final reading of an ordinance to consider an ordinance rezoning a 15.39 acre tract of unplatted land in Section 191, Block 2, AB&M Survey, Potter County, Texas, to change from Agricultural District to Residential District 3. Vicinity: Broadway Drive and West Hastings Avenue. Applicant/s: Tommy Nielsen. This item was presented by Andrew Freeman, Managing Director of Planning and Development Services.

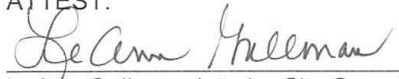

Motion was made by Councilmember Powell, seconded by Councilmember Sauer, to award the contract to LA Fuller & Sons Construction, LTD>

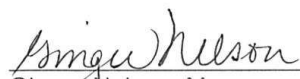

The sale price is for \$220,524.00 plus closing costs and related expenses.
